- (3) Full-time students are not allowed to undertake full-time jobs without the prior approval of SGS.
- (4) Students holding a student visa for study in Hong Kong are <u>not allowed</u> to undertake any full-time or part-time employment during their stay in Hong Kong without the special permission of the Immigration Department. Notwithstanding the approval of this application, such students should still seek special permission of the Immigration Department via their prospective employer.
- (5) As specified in the "Terms and Conditions" of the Hong Kong PhD Fellowship Scheme, HKPF recipients are not permitted to undertake any part-time or full-time paid employment during the fellowship period unless exceptional approval has been given by the Research Grants Council.
- (6) Applications should be made at least two months before the start date of employment.
